



TOWN OF MOUNT GILEAD PARKS AND RECREATION COMMITTEE MEETING MINUTES

The Mount Gilead Parks and Recreation Committee will met Thursday, May 16, 2024 at 5:30 p.m. at Mount Gilead Library, 119 West Allenton Street, Mount Gilead, North Carolina. Present were members Jennifer Haywood, Taryn Gross, Rick Moore, Tara Clark, Town Manager Dylan Haman, and Mollie Lee.

CALL TO ORDER

Jennifer Haywood called the meeting to order at 5:48pm.

ITEM I. ADOPTION OF AGENDA

Rick Moore made a motion to adopt the agenda with a second from Taryn Gross. The motion carried unanimously.

ITEM II. APPROVAL OF THE MINUTES

A. April 18, 2024 Meeting Minutes

Rick Moore made a motion to approve the April 21, 2024 Meeting Minutes with a second from Tara Clark. The motion carried unanimously.

ITEM III. OLD BUSINESS

A. Proposed Ball Field Rental Policy

Town Manager Dylan Haman recommended the Committee to make a recommendation to the Town Board on the policy. He also states that he has made all the changes that were discussed at the last meeting. There was a lot of discussion on the season rate prices and about the insurance for the teams. Town Manager Dylan Haman stated that the season rate fee is for those who do not have a Mount Gilead address. Insurance is needed to cover the teams just in case someone was to get hurt. The Town itself has insurance on the field but NOT on the players that play on the field. With no further discussion, Taryn Gross made a motion to recommend the proposed Ball Field Rental Policy to the Town Board. Tara Clark seconded the motion, and the motion was carried unanimously.
